New Delhi dated 29<sup>th</sup> March, 2020 on COVID-19 Lockdown – reg.**

Sir/Madam,

Reference above, please find enclosed herewith order NO. 40-3/2020-DM-I(A) Dated 29<sup>th</sup> March 2020 received from the Union Home Secretary.

2. It is observed that movement of large migrants have taken place in some part of the country so as to reach their home towns. This is in violation of the lockdown measures on maintaining social distance.
3. Now, in order to deal with the situation and for effective implementation of the Lockdown measures, and to mitigate economic hardship of migrant workers, you are directed to take the following additional measures as per the above Order:
  - i. Ensure adequate arrangements of temporary shelters, and provision of food etc. for the poor and needy people, including migrant labourers, stranded due to lockdown measures in their respective areas.
  - ii. The migrant people, who have moved out to reach their home states/ home town, must be kept in the nearest shelter by the respective District quarantine facilities after proper screening for a minimum period of 14 days as per standard health protocol.
  - iii. All the employers, be it in the industry or in the shops and commercial establishments, shall make payment of wages of their workers, at their work places, on the due date, without any deduction, for the period their establishments are under closure during the lockdown.
