**ORDER**

1. In partial modification of Standard Operating Procedure (SOP) for persons entering Nagaland issued vide NO. ACS/FC/COVID-19/2020/60, dated 14.05.2020, by the Empowered Group, it is hereby ordered that **all persons entering the State from 18<sup>th</sup> May 2020 onwards, irrespective of place of origin of journey shall undergo mandatory 14 (fourteen) days Institutional Quarantine at the designated centers and thereafter proceed for 14 (fourteen) days mandatory Home Quarantine.**
2. In respect of persons above the age of 60 years, children below the age of 10 years and parents and pregnant women and accompanying spouse, they shall be thoroughly screened, and on the advice of the Medical Team at the Quarantine Centre, be sent for mandatory Home Quarantine for 28 (twenty eight) days with active surveillance.
3. The above will not apply to those persons who have already entered the State before 18<sup>th</sup> of May 2020 from Orange/Green Zones and have not crossed Red Zones en route to the State.
4. All other provisions of the SOP issued vide NO. ACS/FC/COVID-19/2020/60, dated 14.05.2020 shall continue to be in effect.
