ADVISORY FOR SECURITY AGENCIES

among security personnel. Therefore, to prevent and control spread of COVID-19 infection, the undersigned Authorized Authority in exercise of the powers conferred by the Nagaland Epidemic Disease (COVID-19) Regulations, 2020 under the Epidemic Disease Act 1897, hereby issue the following advisories to various Security Agencies stationed in the State of Nagaland for compliance of the following preventive & precautionary measures in the interest of public health:

- 1. Ensure strict maintenance of preventive measures- wearing of face mask, physical distancing, frequent handwashing with soap water/ hand sanitizer, respiratory hygiene, provision of adequate ventilation in buildings for proper air circulation, avoid gathering in closed environment by staggering meal timing, avoiding crowded place such as places of worship, canteen etc, to reduce the risk of transmissions.
- 2. Display of awareness materials, playing of audio messages across the units.
- 3. Temporary sealing of area/ barrack/ building within the camp may be imposed in case of clustering of cases to enable contact tracing and House-to-House Surveillance as per SOP.
- 4. Setting up of Isolation Barracks within the camp for management of Flu-like symptoms and suspected cases.
- 5. Setting up of COVID Care Centre (CCC) within the camp for management of asymptomatic positive cases.
- 6. To issue necessary direction to all ranks and files to avoid mingling with colleagues and more importantly with relatives & public while on transit or when outside their camps.
- 7. To approach the District Health Authority for necessary support and training on various aspect of COVID-19 management.
- 8. To setup Sample Collection and registration of multiple users. For which, the District Health Authority, Deputy Commissioner and District NIC will facilitate.
- 9. To ensure deployment of adequate health personnel for effective management of the above mentioned COVID-19 related activities.

This Advisory is in addition to the SOP for Military Personnel issued on 05.06.20 and should be read along with all SOPs issued by the State Government from time to time.
