Subject: Urgent Measures for preventing the spread of COVID-19 in the State.

In view of the rapid surge in the number of COVID-19 cases in the country, and an increase in the number of active COVID-19 cases in our State also in the past few weeks; all the District Task Force (DTF) are advised to urgently convene meetings, and after studying the COVID-19 situation as existing in their respective districts, and taking into account other relevant local factors, may consider taking one or more of the following measures aimed for preventing the spread of COVID-19 on being satisfied that such measures are necessary:

- (a) Restricting the assembly of 4 (four) or more persons from 7 PM to 5 AM in the urban areas.
 - (b) Opening of markets on alternate days especially in the crowded areas.
 - (c) Allowing plying of vehicles with odd and even registered numbers on alternate days in the urban areas.
2. All the District Task Force may also take immediate action on the following:
- a. To identify any person on arrival from outside the State.
 - b. To instruct such persons to immediately report to the DTF.
 - c. To instruct such persons to remain in self-isolation for 10 days, if no negative RT-PCR/TrueNat/CBNAAT test report for COVID-19 (test done not earlier than 72 hours prior to entry into the State) is produced on arrival, or if the test result is awaited, or if the person concerned hasn't completed the COVID-19 vaccination
 - d. To inform all the residents for strict observance of COVID appropriate behaviours including avoiding crowded places and to encourage all eligible persons to avail COVID-19 vaccination.
 - e. To enforce compulsory wearing of face masks.
 - f. To check gathering of crowds beyond permissible limit.
 - g. To start random screening tests in all high risk settings as advised by the Health & Family Welfare Department
3. The District Task Force may submit regular action taken report on the above to this office.
