ORDER

In order to have rational management of oxygen cylinder for the COVID-19 pandemic treatment and care in the State, the following arrangements shall be made;

1. State Depot for oxygen cylinder, Police Complex, Chumukedima

A suitable building/hall in the Police Complex, Chumukedima to be designated as State Depot to keep custody of all Oxygen Cylinders for the State. The site will be utilized to receive all Cylinders procured by the State.

- The Directorate of Health & Family Welfare to detail senior official and adequate staff to maintain proper Registry and accounts of all cylinders being received and distributed to various districts/hospitals.
- Commissioner of Police Dimapur to detail 24*7 security at the premises.
- Suitable rooms for the Health & Family Welfare staffs and the security personnel shall be provided by Police department

2. The District Headquarters designated as Zonal Depots

The following District Headquarters mentioned below shall act as Zonal Depots for the cluster of districts indicated in the bracket and the districts should immediately identify suitable Building/Hall for storing the Reserve Cylinders and make arrangements for manpower and 24*7 security:

- Mokokchung (for Longleng & Zunheboto)
- Tuensang (for Noklak & Kiphire)
- · Kohima (for Phek & Wokha)
- · Mon, Peren will collect from State Depot, Dimapur

3. TRANSPORTATION OF OXYGEN CYLINDERS

All DTFs shall arrange vehicles (Preferably Mahindra Pick-Ups/ or other suitable conveyance) for transportation of Filled in Cylinders/Empty Cylinders from district to Zonal Depot and vice-versa.
