**ORDER**

**Subject: Relaxations of lockdown regulations - Unlock 3**

WHEREAS, total lockdown order to contain and combat the rapid surge of COVID-19 in the State was issued vide this office order of even number dated **11.05.2021**, and further extended vide orders dated **20.05.2021**, **28.05.2021**, and with certain relaxations vide orders dated **09.06.2021**, **16.06.2021**, **30.06.2021** and **09.07.2021**;

AND WHEREAS, the High Powered Committee on COVID-19 in its meeting held on 16.07.2021, further reviewed the COVID-19 situation, and after taking the views of the Health & Family Welfare Department, and the Districts Task Forces decided for continuation of the existing lock down measures with further relaxations and re- opening of more activities, subject to certain conditions and strict adherence to all the applicable Standard Operating Procedures (SOP) for preventing the spread of COVID-19;.

NOW THEREFORE, in exercise of the powers conferred under **Section 22 (2) (b) and Section 22 (2) (h) of the Disaster Management Act 2005**, the undersigned in the capacity of Chairperson, State Executive Committee, hereby directs for extension of the existing lock down measures with effect from 18th July 2021, for 15 (fifteen) more days, up to 1<sup>st</sup> August 2021 in the State, with further relaxations and re-opening of activities as under:


1. Colleges are allowed to reopen from 26<sup>th</sup> July 2021 subject to all the teachers and non-teaching staff having been fully vaccinated (taken both the doses) against COVID-19, or having taken the 1<sup>st</sup> (first) dose of vaccine against COVID-19, and at least 15 (fifteen) days have passed since taking the 1<sup>st</sup> (first dose), and strict adherence to the SOP including the maximum allowable allowed percentage of attendance of the students in the classes to be issued by the Home Department.
2. Schools are allowed to reopen for Class XI and XII, from 2<sup>nd</sup> August 2021, subject to all the teachers and non-teaching staff having been fully vaccinated (taken both the doses) against COVID-19, or having taken the 1<sup>st</sup> (first) dose of vaccine against COVID-19, and at least 15 (fifteen) days have passed since taking the 1<sup>st</sup> (first dose), and strict adherence to the SOP including the maximum allowed percentage of attendance of the students in the classes to be issued by the Home Department.



3. Opening of in-house skill development institutes/ establishments with 50% capacity from 26<sup>th</sup> July 2021 will be permitted, subject to all the trainers, assistants and non-teaching staff having been fully vaccinated (taken both the doses) against COVID-19, or having taken the 1<sup>st</sup> (first) dose of vaccine against COVID-19, and at least 15 (fifteen) days have passed since taking the 1<sup>st</sup> (first dose), and strict adherence to the SOP to be issued by the Home Department.
4. Social, political, religious, entertainment, academic, cultural gatherings and other public gatherings are allowed up to a maximum of 50 (fifty) persons when the events are held indoors, and up to a maximum of 100 (hundred) persons when the events are conducted outdoors, and subject to strict adherence to COVID-19 appropriate behaviours and all the applicable SOPs. In the event of exceptional requirement of holding of function/ program with a larger gathering, the prior permission of the DTF will be required.
5. Opening of restaurants for dine-in, up to 50% capacity are permitted, subject to all the attendants/staff of the restaurants having been fully vaccinated (taken both the doses) against COVID-19, or having taken the 1<sup>st</sup> (first) dose of vaccine against COVID-19, and at least 15 (fifteen) days have passed since taking the 1<sup>st</sup> (first dose), and strict adherence to the applicable SOPs.
6. All the District Task Forces shall map areas for micro-containment zones in case the situation so warrants, as per the detailed guidelines to be issued.
7. The returnees /travellers entering the State, and tourists, who are asymptomatic and fully vaccinated against COVID-19 will not be required to be tested for COVID-19 at the point of entry or required to quarantine. Those who have taken the 1<sup>st</sup> (first) of the vaccine against COVID-19 and at least 15 (fifteen) days have passed since taking the dose, will not be required to be tested for COVID-19 at the Point of Entry but will be required to quarantine for 7 (seven) days. For all other cases, the persons concerned will be required to undergo testing for COVID-19 on payment as per the Government approved rates at the point of entry and further undergo 7 (seven) days quarantine. The DTF Concerned will make arrangements for the screening/ testing and paid quarantine in case adequate and proper facilities for quarantine at home are not available to the persons concerned.
8. Inter-district movement of person for non-essential service or purpose including private journey by light vehicle is allowed subject to the person(s) including the driver being asymptomatic and having completed their COVID-19 vaccination or taken at least a single dose of vaccine against COVID-19 and 15 days have passed since taking the dose.
9. All the Districts Task Forces should enforce the directives issued for displaying the vaccination status of the shops keepers, barbers, taxi drivers etc.



10. Detailed SOPs with regard to Para 1, 2, 3 and 6 will be issued by the Home department in consultation with the departments concerned.
