**ORDER**

WHEREAS, fresh and rapid surge in COVID-19 cases is being noticed in several States of the country, and there has been increased detection of the Variant of Concern, Omicron, indicating arrival of the third wave of COVID-19;

AND WHEREAS, there exist a possibility of surge in COVID-19 cases in the State of Nagaland also, which may put public's health in serious danger, and also strain the health infrastructure of the State;

AND WHEREAS urgent measures are required for preventing the spread of COVID-19 in the State;

NOW THEREFORE, in public interest, and in partial modification of all the earlier orders issued on lockdown measures and relaxations concerning the COVID-19 pandemic, as well as the relevant SOPs issued for the various activities; the undersigned in exercise of the powers conferred under Section 22 (2) (b) and Section 22 (2) (h) of the Disaster Management Act. 2005, in the capacity of Chairperson, State Executive Committee, with a view to break the chain of transmission of COVID-19 and prevent the surge of COVID-19 cases in the State, hereby orders the following restrictions for strict implementation throughout the State of Nagaland with immediate effect up till the 31<sup>st</sup> of January 2022:

- a) Social, political, religious, entertainment, academic, cultural gatherings, and all other kind of public gatherings shall be restricted and allowed **up to 50 % capacity, or up to a maximum of 200 persons, whichever is lower**, and subject to all the participants being asymptomatic, and being fully vaccinated (taken both the doses) against COVID-19. In case there is an unavoidable need to have bigger gatherings, they may be permitted only after getting express permission of the respective District Task Force (DTF).
- b) Night curfew stands imposed from **09:00 PM to 05:00 AM with effect from 9<sup>th</sup> January 2022 in the State**. However, goods vehicles, vehicles transiting the State without any stopovers, movement due to medical and other emergencies, agricultural purposes, and any other movement permitted by the respective DTF will be exempted from the purview of night curfew.
- c) Malls, shopping complexes, restaurants, gymnasiums, cinema halls/theatres, parks, places of entertainment, recreation areas, etc, shall be permitted to open/operate **up to 50% capacity**, and all the visitors/staff and all other concerned, should be asymptomatic, and fully vaccinated (taken both the doses) against COVID-19.
- d) Any person entering the State, above 12 years of age, including those fully vaccinated, shall **be required to carry a negative COVID-19 test report done through RT-PCR/ True Nat/CBNAAT** with the swab given for testing not earlier than 3 (three) days of the date of arrival in the State. If the incoming traveller is not carrying a negative COVID-19 test report, or has a negative report, but is symptomatic, or is below 12 years of age and symptomatic, then he/she will be required to undergo testing for COVID-19 at Government approved rates at the point of entry in the State, and the person concerned will be in home/paid quarantine till the declaration of the test result. The aforesaid provisions will come into **effect from 10<sup>th</sup> January 2022**, and the SOP for entry of persons in the State issued vide this office notification of even number dated 8<sup>th</sup> November 2021 (<https://nsdma.nagaland.gov.in/sites/default/files/2021-12/notification.pdf>) stands modified to this extent.



- e) The physical /offline classes for students studying up to Class VIII stand suspended / closed till 31<sup>st</sup> January 2022.
- f) Any student of Class IX and above, and who has completed 15 years of age, shall be allowed to take admission, or attend regular/offline classes, only if he/she has taken at least one dose of vaccine against COVID-19.

2. Any person/group of persons acting in violation of the above directions, as well as all the other existing orders/SOPs/guidelines, for preventing the spread of COVID-19, shall be liable to be prosecuted against under the relevant sections of the Disaster Management Act, 2005, besides action under Section 188 of IPC and other legal provisions as applicable.
